3. FEED AND FACILITIES

Barn agrees to provide the following, in addition to normal and reasonable care and handling to maintain the health and well being of the horse (s).

All hay is provided. Any dietary requirements must be provided by the OWNER.

Horses will be fed according to owner's request. Horse board will be at a fee of \$7.00 per day.

4. VACCINATIONS

All horses that stay at the foundation must come with an up to date vaccination certificate, No longer than 90 days and not within 14 days and they should include Strep. equi, influenza and rhino.

5. RISK OF LOSS

During the time that the horse (s) is/are in the custody of the BARN. The BARN shall *not* be liable for any sickness, disease, theft, death or injury which may be suffered by the horse. This includes, but is not limited to, any personal injury or disability the horse may receive while of BARN premises. OWNER fully understands and hereby acknowledges that BARN does not carry any insurance on any horse s) not owned by BARN, including, but not limited to, such insurance for boarding or any other purposes, for which the horse(s) is/are covered under any public liability, accidental injury, theft or equine mortality insurance, and that all risks relating to boarding of horse (s), or for any other reason, for which the horse (s) is/are in the possession of BARN, *are to be borne by OWNER*. Vehicles left on the premises are left at the owner's risk.

6. HOLD HARMLESS

OWNER agrees to hold BARN harmless from any claim resulting from damage or injury caused by said horse, OWNER or his guests and invitees, to anyone, including but not limited to legal fees and/or expenses incurred by BARN in defence of such claims.

7. LIABILITY INSURANCE

OWNER warrants that he/she presently carries in full force and effect, and throughout the period of this AGREEMENT shall continue to carry and maintain in full force and effect, liability insurance protecting OWNER and BARN from any and all claim (s) arising out of or relating to this AGREEMENT.

8. EMERGENCY CARE

BARN agrees to attempt to contact OWNER, at the following emergency telephone number (_____), should BARN feel that medical treatment is needed for said horse (s), provided however, that in the event the BARN is unable to so contact OWNER within a reasonable time, which time shall be judged and determined solely by BARN, BARN is then hereby authorized to secure emergency veterinary care and/or blacksmith care, and by any licensed providers of such care who are selected by BARN, as BARN determines is required for the health and well-being of said horse (s). The cost of such care secured shall be due and payable by OWNER within fifteen days from the date OWNER receives notice thereof, provided however, that BARN is authorized to arrange direct billing by said care provider to the OWNER.
